## SEWP V General Overview

The SEWP V contract is a government-wide acquisition contract (GWAC) for Information Technology products and services. It is an indefinite delivery, indefinite quantity (IDIQ) contract, for use by all Federal Agencies and approved federal agency support contractors. Starting on May 1, 2015, SEWP V has Maximum value of 20 Billion US\$ and has a performance period of 10 years (5 base and 5 1 year options)

SEWP V offers Advanced technology solutions including IT Virtualization, Infrastructure Consolidation, AV solutions, Servers, IT peripherals, Network equipment, Storage systems, Security tools, Software, Cloud based services, infrastructure equipment. Product based services such as installation, training, maintenance and warranty are also available through SEWP.

The SEWP V Business Operations & Workstation Laboratory (BOWL) manages the SEWP V program, and applies a small administration surcharge (.36%) on all contract orders. SEWP V administration surcharge shall not be shown separately and must be included as part of the item pricing.

The recommended method is using the SEWP Quote Request Tool (QRT) available on the SEWP Website ([sewp.nasa.gov](http://sewp.nasa.gov)). Use of this tool assists in providing and documenting Fair Opportunity and verifying and assuring items quoted are on the contract and properly priced. All SEWP quotes and orders MUST go through the SEWP Bowl
