SEWP V General Overview

The SEWP V Contract (Solutions for Enterprise-Wide Procurement) is a government-wide acquisition contract (GWAC) for Information Technology products and services. It is an indefinite delivery, indefinite quantity (IDIQ) contract, for use by all Federal Agencies and approved federal agency support contractors. Starting on May 1, 2025, SEWP V has Maximum value of \$20 Billion USD and has a performance period of 10 years (5 base and 5 1-year options).

SEWP V offers advanced technology solutions including IT Virtualization, Infrastructure Consolidation, AV Solution, Servers, IT Peripherals, Network Equipment, Storage Systems, Security Tools, Software, Cloud-Based Services, and Infrastructure Equipment. Product based services such as installation, training, maintenance, and warranty are also available through SEWP.

The SEWP V Program Management Office manages the SEWP V Program and applies a small administration surcharge (.34%) on all contract orders. The SEWP V administration surcharge shall not be shown separately and must be included as part of the item pricing.

SEWP recommends utilizing the Quote Request Tool (QRT) and Marketing Research Tool from their website (www.sewp.nasa.gov) to assist customers with their buying decisions. Fair Opportunity FAR 16.50(b) (1) provides that each contractor shall be given fair opportunity to be considered for each order exceeding \$10,000 and issued under multiple award contracts. By using the Quote Request Tool, customers are not required to obtain 3 quotes as long as all Contract Holders within a group or set-aside were provided the opportunity to provide a quote.
